**OFFICE ORDER No. 173 /2022(Civil).**

The agency, M/s Pitam Singh Construction Co. is enlisted in DDA as Class-V(Civil) vide this office order No. 52/2021(Civil) dated 24.02.2021. The enlistment of the agency is valid upto 23.02.2026. It has been recommended by CE(NZ), DDA vide F.8(23)A/Co/NMD-1/DDA/2021-22/23 dated 17.01.2022 that the case of M/s Pitam Singh Construction Co. for suspension/debarring for tendering in DDA for a period of one year as per terms and condition of the NIT mentioned below:

1. If after the opening of tender, I/We withdraw or modify my/our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents.
- or
2. If after the award of work, I/We fail to sign the contract, or to submit performance guarantee before the deadline defined in the tender documents
3. I/We shall be suspended for one year and shall not be eligible to bid for tenders from date of issue of suspension order


The Executive Engineer, NMD-1, DDA vide his letter No. F8(23)A/C/NMD-1/2021-22/657 dated 24.11.2021 requested M/s Pitam Singh Construction Co. to submit performance guarantee but the agency has not turned up to deposit PG in this regard.

Accordingly, show cause notice has been issued to the agency and the agency has given reply vide letter dated 08.03.2022 showing his inability to deposit PG due to his accident through motorbike and got fracture in his right leg and doctor provided plaster on his right leg and advised not to do anything for one month.


The case of above said agency was put up before the board on 06.09.2022; the board deferred the case to the next meeting and desired that to get the proof of medical illness/accident from the firm/agency/ contractor. Accordingly, the agency was requested vide this office email dated 19.09.2022 to submit the proof of his medical illness/accident. The agency vide his letter dated 07.10.2022 (received in this office on 11.10.2022 vide Dy. No. 474) submitted documents related to his medical illness/accident.

The documents submitted by the agency were put up before the board on 19.10.2022. The board after due deliberation and discussion observed that the documents submitted by the agency are not convincing. Therefore, the board recommended debarment of the above mentioned firm/agency/contractor for a period of one year from tendering in DDA. On the recommendation of the board, the competent authority allowed the debarment of the contractor for a period of one year. **Accordingly, M/s Pitam Singh Construction Co. is hereby debarred/ suspended for one year from the date of issue of this order for further tendering in DDA.**
