CIRCULAR No. 61

Sub: Final Seniority List of Asstt. Director (Planning) [(GP 5400/- Pay Band- 15600-39100) (Level 10 in Pay Matrix as per 7th CPC)]

The tentative Seniority List of Asstt. Director (Planning) from Seniority No. 31 to 96, was circulated for inviting objections/suggestions, if any, within 10 days from issue of the list vide Circular No. 22 dated 16.08.2021. The objections/ suggestions were examined in the light of extant guidelines as follows:-


1. DDA has followed the orders of Hon'ble High Court dated 30.09.2019 in WP(C) No. 8469/2009 titled Ashwani Khullar v. DDA &Ors., WP(C) No. 8479/2009 titled Ambuj Sood Vs. DDA &Ors., WP(C) No. 13931/2018 titled Shri Kanwal Kumar Vs. Union of India and Ors. for carrying out review DPCs. It may also be noted that Hon'ble High Court of Delhi vide order dated 13.05.2009 in WP(C) No. 8469/2009 titled Ashwani Khullar v. DDA & Ors., WP(C) No. 8479/2009 titled Ambuj Sood V. DDA & Ors. had directed that "promotions already made or further promotions if any that would be made shall be subject to the outcome of the writ petition." Accordingly, all officials in the cadre are covered under the ambit of the judgment and thus revised seniority list will also be applicable to all the officials of the cadre.
2. Since, the Hon'ble Supreme Court has not passed any interim orders/stay in respect to the orders of Hon'ble High Court; the final seniority list has been prepared as per orders/ directions of Hon'ble High Court. However, the seniority list will be subject to the judgment of Hon'ble Supreme Court.
3. DDA has followed the orders of Hon'ble High Court and accordingly review DPCs have been carried out. The final seniority list will however be subject to the judgment of Hon'ble Supreme Court.
4. The seniority list has been determined as per the provisions of DoPT OM No. 20011/2/2019-Estt. (D) dated 13.08.2021.

Accordingly, above mentioned tentative seniority list of Assistant Director (Planning) from Seniority No. 31 to 96 is finalized with the approval of Competent Authority and the same is hereby published as per Annexure- A.


